# **Inter-Institutional Agreement**

# Key Action 1 Learning Mobility for Higher Education Students and Staff among EU Member States and third countries associated to the Programme Title: D HALLE01\_0232 - Literature and Linguistics; 023 - Languages\_I MESSINA01

The institutions agree to cooperate for the exchange of students and/or staff in the context of the Erasmus+ programme.
