# Key Action 1 Learning Mobility for Higher Education Students and Staff among EU Member States and third countries associated to the Programme Title: P AVEIRO01 - 0410 Business and administration- I MESSINA01

The institutions agree to cooperate for the exchange of students and/or staff in the context of the Erasmus+ programme.
