- the availability, in the event of the assignment of a PR FSE+ Sicilia PhD scholarship in co-tutoring (**type B**), to carry out the research topic of the PhD training course in collaboration with the Research Institute, IRCCS or Research Body identified by the University, as reported in the PhD Call – **41<sup>st</sup> cycle** – **Attachments nos. 1-16**.
