### STUDENTS SELECTION CALL FOR THE DOUBLE DEGREE PROGRAMME “UniME-AGH” MOBILITY DURING THE ACADEMIC YEAR 2025/2026

The Department of Economics of the University of Messina (from now on UniME) selects no more than n.10 students enrolled in the first year (A.Y. 2025/26) of the Master's Degree Course in “Consulenza e Gestione di Impresa (curriculum International Management)”, to participate in the Double Degree programme in International Management with the AGH University of Krakow (from now on AGH) (Poland).

UniME subscribed an agreement with AGH for the establishment of a structured mobility pathway for obtaining a Double Degree within the Master's Degree Program in Consulenza e Gestione d'Impresa (International Management curriculum) at UniME and the Master Degree in International Management at AGH.

Students selected within this call will opt for a double degree programme based on the following study programme:

It should be highlighted that the current study programme detailed above may be subject to changes agreed upon by UNIME and AGH. These changes will be communicated to students enrolled in the Dual Degree programme in a timely manner.



**Successful students will get a Double Master Degree issued by UniME and AGH.**

Selected students from UniME will attend the first and fourth semester at UniME and the second and third semester at AGH, according to the organization of the Academic Year applicable to the study period at the respective universities as established in the above scheme.

The partner universities mutually recognize the credits acquired by the student for the provision of the double degree in International Management. A tax waiver policy will be adopted, according to the provisions of the specific agreement stipulated between UniME and AGH (available at the link: <https://consulenza-e-gestione-di-impresa.cdl.unime.it/it/studiare/double-degree-international-management>).

**Eligibility**

In order to participate to this call, students must be enrolled in the first year of the Master's Degree Course in *Consulenza e Gestione di Impresa/Business Consulting and Management (International Management curriculum)* for the A.Y. 2025-2026 at UniME and must have completed a First cycle Degree course with a final graduation mark of at least 100/110 in the Italian evaluation scale or corresponding to 100/110 in other international evaluation scales.

Participation in this Call is permitted to undergraduates of the October 2025 graduation session who have pre-enrolled in the First Year of the Master's Degree Course in Consulenza e Gestione di Impresa/Business Consulting and Management (International Management curriculum) for the Academic Year 2025/2026, provided that they complete their enrollment no later than October 31, 2025.

**Terms and conditions for the submission of the application**

The application must be drawn up on plain paper, according to the attached model (Attachment 1), duly dated and signed, under penalty of exclusion, accompanied by a valid identity document. The application MUST be submitted in pdf format via email to [protocollo@unime.it](mailto:protocollo@unime.it) and, in carbon copy, to the Coordinator of the Master Degree Course, Prof. Giovanna Centorrino (e-mail: [giovanna.centorrino@unime.it](mailto:giovanna.centorrino@unime.it)), and to [dipartimento.economia@unime.it](mailto:dipartimento.economia@unime.it) indicating in the object field of the e-mail "Domanda per selezione Doppio titolo Messina – AGH, Master Degree in International Management", **by and no later than thirty days after the date of publication of this Call.**

**Candidates must enclose to the application form the following documents**

1. Valid identity document.
2. A transcript of records (list of exams taken and relative marks) of the First Cycle Degree course and Final Graduation Mark (at least 100/110 in the Italian evaluation scale or corresponding to 100/110 in other international evaluation scales).
3. Certification attesting the B2 level of knowledge of the English language (B2 level of knowledge of the language of Studies (English) as defined by the Common European Framework of Reference (CEFR) for Languages).
4. CV in English duly signed.
5. Substitute declaration of certification according to the DPR n. 445/2000 attesting the enrollment or pre-enrollment in the first year of the Master's Degree course in Consulenza e Gestione di Impresa/Business Consulting and Management (International Management curriculum), University of Messina.

Pre-enrollment is permitted only for graduating students of the October 2025 Session, provided that they complete their enrollment no later than October 31, 2025

Candidates who have obtained a First Cycle Degree degree abroad and other qualifications abroad must produce the degree certificate and other certificates certifying the achievement of these qualifications, according to current legislation, not being able to make use of self-certification limited to states and facts not verifiable by the Italian administration.

In the case of the B2 level of knowledge of the English language, it is necessary to attach the Certificate, as required by the AGH University of Krakow to which this certificate must be sent.

In the event of a tie, priority will be given to the youngest candidate.

Applications received after the indicated deadline or produced and/or received in different ways or with incomplete documents, will be excluded.

UniME reserves the right to ask, selected students, for any further additional documents if requested by the host Institution.

### **Evaluation Criteria**

The ranking will be based on the final degree mark. In case of a tie, priority will be given to the youngest candidate. In the case of October 2025 graduates, the selection will take into account the average exam results. In case of a tie, the priority will be given to the youngest candidate.

### **Selection Committee and final ranking**

The selection Committee is appointed by the Academic Board of the Master's Degree Course. The composition of the selection Committee will be published, after the expiry date of the present notice, on the department website at the address <https://www.unime.it/bandi-e-concorsi/studenti> with notification value from the University.

The final ranking, based on academic merit, will be published on the department website and on the section amministrazione trasparente of the UniME website <https://www.unime.it/bandi-e-concorsi/studenti>

### **Acceptance and waiver**

The candidates usefully positioned in the final ranking will be selected for the double degree programme.

The selected candidates will be required to communicate their acceptance within 7 days from the publication of the selection results to [protocollo@unime.it](mailto:protocollo@unime.it) and to [dipartimento.economia@unime.it](mailto:dipartimento.economia@unime.it) under penalty of forfeiture of the right to participate in the program.

By this deadline, those who have submitted the pre-enrollment will also have to complete the enrollment in the first year of the Master Degree Course in Consulenza e Gestione di Impresa (curriculum International Management), University of Messina.

In case of withdrawal, exclusion or forfeiture of a selected candidate, the ranking list will be scrolled down to the following candidate.

The scroll notification will be sent to the suitable candidate, usefully placed in the ranking. Within the peremptory deadline of 3 days from the communication, the candidate must explicitly and unequivocally consent to the scrolling of the ranking in his favour sending an email to [protocollo@unime.it](mailto:protocollo@unime.it) and to [dipartimento.economia@unime.it](mailto:dipartimento.economia@unime.it)

After this period, the candidate will be considered tacitly renouncing.

### **Obligations**

All students participating in the Double Degree program who will be selected through this announcement are required to produce at the International Cooperation Unit ([cooperazione@unime.it](mailto:cooperazione@unime.it)) the documentation relating to their mobility (Learning Agreement before



the start of the stay, Certification of the mobility period and Transcript of Records at the end of stay). Please note that, for the purpose of enrollment at the partner university AGH (Poland), each selected student is required to submit to AGH the documentation requested by the partner university, accompanied by an apostille and a sworn translation into Polish. Selected students are advised to obtain the required documents well in advance of the start of their mobility period. All costs related to these requirements are the sole responsibility of the selected students.

### Support to mobility

Students selected under this Call, if not awarded an Erasmus+ grant and/or other financial support for international mobility at the Partner university, may benefit from the financial contribution that the University allocates to students undertaking an international mobility programme for the achievement of a double degree ("UniMe double degree contribution"), in accordance with the resolutions of the Academic Bodies (prot. no. 81242 of 23/06/2022 and prot. no. 81219 of 23/06/2022), up to the maximum amount of the allocated budget of €23,350.00.

The UniMe double degree contribution will be awarded by the Selection Committee based on the merit ranking.

Specifically:

- for the first mobility semester at AGH (second semester of the first academic year at UniME), selected students may benefit from the UniMe double degree contribution provided they are not recipients of an Erasmus+ grant or other financial contributions/subsidies and/or economic support for international mobility at the host university;
- for the second mobility semester at AGH (first semester of the second academic year at UniME), students who have received the UniMe double degree contribution for the first mobility semester may continue to benefit from the assigned contribution on the condition that they apply for the Erasmus+ KA131 UniMe Call for study, reserved for the Double Degree Programme at AGH, and are not awarded the Erasmus+ grant.

The UniMe double degree contribution, consisting of a one-off travel allowance of €275.00 and a monthly contribution determined according to the table below, will be paid in the amount of 80% at departure and 20% upon return from mobility.

The travel contribution of €275.00 may be paid to the student together with the grant or, alternatively, upon request, as a reimbursement of expenses. In such case, the student acknowledges and accepts

that, should the documented expenses be lower than the maximum amount of the travel contribution indicated, no payment will be made for the portion exceeding the actual expenses incurred; furthermore, should the documented expenses exceed the maximum amount of the contribution, no additional reimbursement will be granted.

The financial contribution is subject to taxation, in accordance with Article 50, paragraph 1, letter c) of the TUIR (Presidential Decree no. 917/86), as clarified by the Italian Revenue Agency (Ruling no. 171/2022).

Mobility contributions represent only a financial supplement intended to cover part of the costs arising from the stay abroad and are not meant to cover all the expenses that the student will incur during the mobility period.

Students are hereby informed that any costs related to the documentation required by AGH University for enrolment purposes, including those for any official translations of certificates or other documents, shall be entirely borne by the students concerned.
