ACADEMIC EXCHANGE AGREEMENT
BETWEEN
UNIVERSITA' DEGLI STUDI DI MESSINA
AND
NAGOYA CITY UNIVERSITY

Università degli Studi di Messina, Italia and Nagoya City University, Japan hereby conclude this agreement to promote educational and academic exchange and cooperation between the two universities.

1. Each university will make an effort to promote and develop cooperation in the following activities, upon the principles of equality and reciprocity:
 - (1) Exchange of faculty member, research fellows and technical-administrative staff
 - (2) Exchange of students
 - (3) Exchange of academic materials, publications and information
 - (4) Conducting joint research projects and organizing symposiums
2. In order to carry out the above-mentioned activities, an agreement will be exchanged after mutual consultation between the two universities. However, each institution does not assume any financial responsibilities by this agreement.
3. The agreement shall come into effect on the date of the signatures to the agreement and shall be valid for a period of five years. Either party may withdraw this agreement by giving six months prior notice in writing of such intent. After five years, this agreement may be renewed in writing
