# IT IS HEREBY DECREED

# ART.1. ACTIVATION of Level I/II Master's in Total Quality International Management for Food 5.0, academic year 2025/2026.

### 1.1 General Provisions

For the 2025/2026 academic year, the Level I Master's in Total Quality International Management for Food 5.0 will be offered at the University of Messina with a capacity of 60 students. The Master's program will be coordinated by its designated department.

The program will be launched provided that, following the selection process, at least 10 students enroll, as required by the regulations governing advanced training courses.

# 1.2 Objectives and Structure of the Master's Program

The Master's courses are designed to deliver specialized expertise and in-depth cultural knowledge in fields and issues of high professional relevance, ensuring strong connections to the job market and local communities.

A university Master's program lasts 12 months. To earn the Master's degree



Students must have earned at least 60 University Educational Credits (CFU).

Earning credits for various advanced training and development activities requires passing both ongoing and final assessments of the skills gained within each area of study.

To be awarded the university Master's degree, candidates must pass a final exam that evaluates all the competencies acquired, including those gained during the internship (stage).

# 1.3 Attendance and Midterm/Final Assessments of Academic Progress

Instruction for participants will be delivered through in-person lectures, as well as online sessions via Teams or other digital platforms, and hands-on internships, all structured according to the guidelines outlined in the document attached to this announcement.

Students are required to attend at least 75% of each course, both theoretical and practical parts. Every educational and support activity must take place under the direct supervision of tutors appointed by the Technical Scientific Committee, based on the Director's recommendation.

The Technical Scientific Committee reserves the right to suspend or remove a participant if they fail to meet attendance requirements, do not maintain payment regularity, or do not pass midterm and final assessments.

# **ART. 2. ADMISSION REQUIREMENTS**

### 2.1 REQUIRED QUALIFICATIONS

Admission to a Master's program requires possession of the following academic qualifications:

- First Level Master's: a Bachelor's degree or higher, a first-level academic diploma, or an equivalent qualification obtained in Italy or abroad and recognized as suitable under current regulations.
- Second Level Master's: a pre-reform degree (before Ministerial Decree 509/99), a specialized degree, a Master's degree, a second-level academic diploma, or another equivalent or foreign qualification recognized as suitable under current regulations.

The specific requirements for the First Level Master's in Total Quality International Management for Food 5.0 are detailed in the information sheet attached to this announcement.

The applicant must, under penalty of exclusion, certify that they meet the admission requirements cited above, in accordance with D.P.R. 445/2000 and its subsequent amendments and supplements, in



in accordance with the provisions set forth in Article 6 below.

All applicants are conditionally admitted. During each stage of the process, the Administration will exclude those who do not meet the qualifications and admission requirements specified in the competition notice and/or declared.

## 2.2 PROVISIONS FOR SIMULTANEOUS ENROLLMENT IN TWO STUDY PROGRAMS

It is permitted to enroll simultaneously in a Master's program and another study course offered at this or other universities, within the limits established by D.M. No. 930 of July 29, 2022. Details on eligibility can be found at:

If one of the two programs requires mandatory attendance, you may enroll in a second program only if it does not require attendance, except for those programs where attendance is mandatory

solely for lab work or internships. In such cases, approval from the Academic Boards of both programs is required.

During the application process, each candidate must attach a self-certification regarding attendance in the first program, along with the relevant study plan.

# 2.3 GUIDELINES FOR INTERNATIONAL APPLICANTS

Candidates who are citizens of the European Union, or citizens of countries outside the European Union, and hold degrees from foreign universities may apply if they have an academic qualification that matches, in duration and content, the Italian degree required for admission. The qualification must meet the requirements outlined above.

## RECOGNITION OF ACADEMIC OUALIFICATIONS

If your degree was earned abroad and has not yet been recognized, your admission will depend solely on the Evaluation Committee's assessment of your qualification for this purpose.

In this case, the applicants in question must provide supporting documents to enable the School Council to assess the eligibility request:

The application for admission must include the following documents:

- Original diploma. Applicants who are citizens of EU Member States may self-certify this;
- official Italian translation, required only if the diploma is not issued in English, French, or Spanish. Those in need may use local translators and then request certification of the translation's accuracy from the Italian consular office for their area (see

https://www.esteri.it/mae/it/servizi/italiani-all-estero/traduzione-e-legalizzazione-documenti.html);



- Legalization, issued by the competent authority confirming the authenticity of the academic credential. Legalization is not needed if the country of issuance is a signatory to the Hague Convention (1961). In such cases, an Apostille serves as validation of the document's authenticity. Additionally, legalization is not required for diplomas granted by institutions in Belgium, Denmark, France, Ireland, Latvia (Brussels Convention 1987), Germany (Rome Convention 1969), or Austria (Vienna Convention 1975). 5 or
- Statement of value, issued locally by the Italian Consular office responsible for the area where the foreign institution granting the degree is based.

If the academic credential is issued by a country whose legislation requires legalization, Italian Embassies will provide the statement of value only after the credential has been legalized by the authorized body in that country.

The declaration of value must include the date and final degree grade, along with details on the grading system used for the academic qualification awarded abroad (including the minimum and maximum possible grades). If a conversion of the final degree grade is needed, the Examining Committee will make this determination based on the information provided by the Italian Consulate regarding the grading system and scale of the country where the degree was obtained. If the submitted documents do not provide sufficient data, the Committee will automatically assign the lowest possible grade.

The declaration of value may be replaced by the Diploma Supplement, prepared according to the European Commission's template, for academic degrees awarded by institutions in countries that are part of the European Higher Education Area.

The declaration of value can also be substituted by certifications issued by CIMEA, which serves as Italy's ENIC-NARIC center. These certifications must include all the information required for evaluating the academic qualification, as outlined in the declaration of value (https://www.cimea.it/).

Community citizens, regardless of where they live, and non-community citizens who have legally resided in Italy for at least one year (pursuant to Article 39, paragraph 5 of Legislative Decree July 25, 1998, No. 286, as amended by Article 26 of Law July 30, 2002, No. 189), and who hold a degree obtained abroad, are eligible to apply under the same conditions and requirements as Italian citizens.

### APPLICANTS WHO ARE NOT RESIDENTS IN ITALY

Non-community applicants are subject to the regulations currently in force and the guidelines issued by the Ministry of Universities and Research.



The pre-enrollment application must also be submitted through the Universitaly portal (<a href="https://universitaly-private.cineca.it/index.php/registration/firststep">https://universitaly-private.cineca.it/index.php/registration/firststep</a>), and will be validated after admission to the advanced training course.

## 2.3 APPLICANTS WITH DISABILITIES OR WITH A DSA DIAGNOSIS

Applicants with disabilities, as defined by Law No. 104 of February 5, 1992 and its subsequent amendments, and those with specific learning disorders pursuant to Law No. 170 of October 8, 2010, are entitled to use appropriate aids or compensatory measures and receive additional time for accessing educational activities and/or for taking intermediate and final exams, provided they submit the necessary medical certification during the enrollment phase.

Applicants with disabilities or DSA who reside in foreign countries and wish to request accommodations must submit legalized documentation certifying their disability or DSA status, issued in their country of residence, along with an official translation exclusively in Italian or English.

The University's designated bodies will review the submitted documentation to confirm that foreign certifications clearly indicate a disability or a specific learning disorder recognized under Italian law.

### 3.2 APPLICATION PROCEDURE FOR THE COMPETITION

To take part in the Master's admission competition, applicants must:

- 1. Fill out the application form using only the online pre-registration process available at <a href="https://unime.esse3.cineca.it/Home.do">https://unime.esse3.cineca.it/Home.do</a>, which can be accessed from any computer with an internet connection, no later than the deadline specified in section 3.1. Late applications will not be accepted. Applications submitted in person, by mail, email, or PEC will not be accepted.
- 2. When filling out your application, pay the €50.00 (fifty/00) fee for the competition organization using the PagoPA system as instructed. Failure to pay will result in exclusion. This fee is refundable only if the course is not activated.
- 3. Once you've finished the process, it's recommended to print out your application form.

The following documents must be uploaded in .pdf format to the designated sections on the esse3 platform, along with your application from step 1:

- self-certification of your degree, including the award date, final grade, and list of completed exams, showing the name of each subject, the respective SSD code, number of credits, exam date, and grade, as required by D.P.R. no. 445/2000;
- photocopy of a valid form of identification, signed by the applicant;
- self-certification stating concurrent enrollment in another course of study for those applying to the Master's program as a second course, in accordance with D.P.R. no. 445/2000;
- self-certification of employment status at public administrations for those seeking benefits under the PA 110 e lode agreement, as per D.P.R. no. 445/2000 (if applicable);
- for applicants requesting accommodations under section 2.3, a copy of a disability certificate or law 104/92 as required by law.

## All applicants will be conditionally admitted to the selection process.

The Administration may, at any time and with appropriate justification, disqualify candidates who do not meet the required criteria. Notification of such decisions will be sent to the concerned individual via PEC.



Likewise, if any false or misleading statements are found in the documents submitted by an applicant, and without prejudice to any penalties under criminal law and specific regulations (Articles 75 and 76 of Presidential Decree No. 445/2000), as well as the possibility of claims for damages by third parties, the applicant's enrollment at the School

will be canceled, any benefits granted will be revoked, and all tuition and university fees paid—including the €50.00 competition participation fee—will be retained.

# **ART. 4. SELECTION COMMITTEE**

The Selection Committee consists of members from the Technical Scientific Committee, supported by the administrative office. The names of the committee members are listed on the form attached to this announcement.

## ART. 5. LIST OF ADMITTED CANDIDATES – GENERAL MERIT RANKING

Admission to the Master's program will be granted to those who, based on the number of available spots, rank within the cutoff position on the list compiled from the total score received after evaluation of qualifications.

The overall merit ranking will be published on the university's website in the news and announcements section of the Master's dedicated page at https://www.unime.it/didattica/post-laurea/corsi-di-alta-formazione-master-e-corsi-di-perfezionamento. This publication will serve as the sole official announcement of the admission test results.

Candidates who are ranked within the cutoff must enroll in the specialization course by the set deadline and in accordance with the procedures outlined in Article 6 of this notice, "ONLINE ENROLLMENT PROCEDURE."

## ART 6. ONLINE ENROLLMENT PROCEDURE

All candidates who have qualified for the ranking must complete their enrollment no later than the deadline specified in section 3.1, using ONLY the online process by accessing the website <a href="https://unime.esse3.cineca.it/Home.do">https://unime.esse3.cineca.it/Home.do</a>. The following steps must be completed through this portal:

- Pay the first installment of university fees (which includes the Regional Fee for the Right to Study, virtual stamp, and insurance) through PagoPA;
- Upload a scanned copy of your ID and tax code;
- If you reside abroad, upload a copy of your official Italian tax code and residence permit.

Failure to complete these steps within the specified deadline will be considered a withdrawal.



If any winners decline to enroll or if any other circumstance leads to available spots from the announced list, the designated Office will post a notice about the updated ranking on the University website. This notice, including details on the specific Master's program, can be found at

https://www.unime.it/didattica/post-laurea/corsi-di-alta-formazione-master-e-corsi-di-perfezionamento. Candidates next in line on the merit list must complete their enrollment by the deadline specified in the notice.

# ART. 7. TUITION AND FEES FOR ATTENDANCE

**7.1 PAYMENT METHODS** Anyone enrolling in a master's program is required to pay the tuition and fees outlined in

the attached schedules. Payments can be made using the following methods:

- The first installment (which includes the Regional Tax for the Right to Education, Virtual Stamp, and insurance) amounts to €2,500.00 (two thousand five hundred/00 euros) and must be paid at the time of enrollment. Late payment of this installment is not permitted; failure to pay by the deadline will be considered a withdrawal from the master's program.
- The second installment, totaling €1,000.00 (one thousand/00 euros), must be paid within one month of the enrollment date.

The first installment of the enrollment fee must be paid in full at the moment of enrollment.

# 7.2 INSURANCE COVERAGE

All students enrolled at the University are covered by a specific insurance policy for accidents related to educational activities.

## ART. 8 FINAL EXAM AND DEGREE AWARD

At the end of your coursework, a final exam will be held as outlined in the attached documents.

To be eligible for this exam, students must have passed all required intermediate assessments and completed payment of all related fees.

At least twenty days before the scheduled final exam date, candidates must submit their degree application by logging into their personal esse3 account and following the provided instructions (https://archivio.unime.it/sites/default/files/guida%20conseguimento%20titolo\_0.pdf).

The exam is conducted in person before an official Examining Committee. Grades are awarded on a scale of 110, with the possibility of receiving honors for top marks. A minimum score of 60 out of 110 is required to pass.

### ART. 9 APPOINTMENT OF PROCEDURE SUPERVISOR



In accordance with Law 241/90, the person responsible for the administrative proceeding is designated as follows:

- The Master's Director for all matters related to the admission process up to the publication of the ranking list; 10
- Dr. Maria Franzò, Head of the Master's Operational Unit, for the publication of this notice on the university website, as well as for collecting and forwarding admission applications and overseeing the enrollment process.

Applicants are entitled to access documentation related to the selection process, as outlined in Chapter V of Law 241/90 and the implementing regulation D.P.R. No. 184/2006.

For documents subject to publication requirements under Article 19, paragraphs 1 and 2, of Legislative Decree 33/2013, access procedures are governed by the aforementioned legislative decree.

## ART. 9. PROCESSING OF PERSONAL DATA

The personal data of applicants will be handled in accordance with the European General Data Protection Regulation 679/2016.
